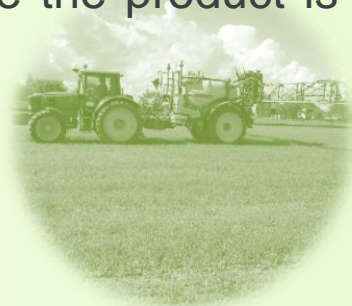
Phytosanitary Act (amendment 2023)

§ 38 b

...

If the product for the given use is authorized according to the directly applicable regulation of the European Union on placing plant protection products on the market in a Member State from the same zone as the Czech Republic, the Institute will, after carrying out an expert assessment, authorize the product for own use in the form of mutual recognition or mutual recognition of an extended permit for minority uses.

(2) In the case of authorization according to paragraph 1, the conclusions of the assessment of the effects on human health, including the corresponding parts of the instructions for use, are taken from the Member State where the product is authorized and no official opinion of the Ministry of Health is required.



Mutual recognition

- Evaluation of effects on human health in case of mutual recognition was canceled by law
- The conclusions from the other country are accepted "without change", but...
- Each country has different outputs, e.g. for
 - Classification
 - PPE
 - Amateur use
 - Areas used by the general public



Example of DE label

SB110: The instruction for requirements for personal protective equipment in plant protection "Personal protective equipment when handling plant protection products" of the Federal Office for Consumer Protection and Food Safety must be followed."

Example of DE label

NT102: The application of the preparation must be carried out in a width of at least 20 m from the adjacent area (with the exception of agricultural or horticultural areas, roads, paths and squares) with a drift-reducing device, which is entered in the list of "drift-reducing devices" dated 14 October 1993 (Federal Gazette No. 205, p. 9780) in the currently valid wording, at least in the reduction class of 75%. When using the product, the use of loss reduction technology is not required if the application is carried out using portable plant protection equipment or if the adjacent areas (e.g. field edges, hedges, groves) are less than 3 m wide or if the product is used in an area that it is listed in the Biologische Bundesanstalt in the "Register of Regional Shares of Small Structures" of February 7, 2002 (Federal Gazette No. 70a of April 13, 2002) as currently valid, and has been designated as an agricultural landscape with a sufficient proportion of small buildings.

Mutual recognition - consequences

The following will not be mentioned in the decisions on mutual recognition

a) Not classification, but the obligation to classify the product properly on the label

b) PPE - there will only be a reference to the obligations to follow the data on PPE and first aid on the label

- Impact on the PPP Register



Mutual recognition – minor uses

In case the producer does not support the MR and the dossier is not available:

- New provision o MR for own use of the farmer
- References to the original label
